

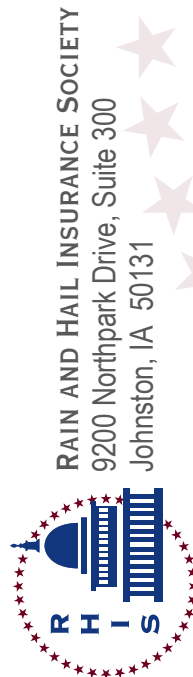
HOW TO INFLUENCE PUBLIC POLICY

RHI SOCIETY PAC

The PAC was formed to help in the election of candidates for public office who have demonstrated support of rural development issues such as crop insurance through the private sector. Your contribution will help advance this process.

Persons who are Society members may participate in the PAC.

HOW TO PARTICIPATE

- Participation can be made on an individual basis using a personal check (preferred method) or by using a company check (see bold, asterisk statement below regarding limitation to corporations). If you choose to contribute to the RHI Society PAC using a company check, please provide the following information:

***RHI Society PAC contributions may not be made using corporate funds. Federal law prohibits RHI Society PAC from accepting contributions from corporations.**

- All checks should be made payable to RHI Society. Checks made payable specifically to the RHI Society PAC cannot be applied to a membership fee. If you wish to donate funds to the RHI Society PAC, please indicate your preferences on the form to the right.
- Corporations may make donations to the Rain and Hail Insurance Society Administrative Fund to defray some of the expenses incurred in printing, postage, photocopying and other administrative costs.
- Complete the Contributor Information Form and forward it with your check to the attention of the RHI Society Treasurer.

FUND USE

- Educational purposes to help inform public officials of the value of crop insurance in their communities, districts and states.
- The election and re-election of candidates who have demonstrated or are committed to supporting RHI Society-PAC goals and objectives.

**Federal law requires political committees to report the name, mailing address, occupation, and name of employer for each individual whose aggregate contributions are in excess of \$200 in a calendar year. PAC contributions will be used for political purposes. Contributions to PAC are not tax deductible as charitable contributions for Federal income tax purposes. Contributions to the PAC are strictly voluntary and you may refuse to contribute without reprisal. Federal law also prohibits RHI Society PAC from accepting contributions from corporations.
